**NOTICE OF ELECTION**

Notice is hereby given that: -

- (1) an election is to be held of a member to the Mizoram Legislative Assembly in **15 – Aizawl West - I (ST)** Assembly Constituency.

OR

- (1) an election is to be held of a member(s) to the Council of States/

- (2) nomination papers may be delivered by a candidate or by any of his

noon on 21.10.2023 (Saturday)** at the Office of the Returning Officer i.e.  
the **Deputy Secretary, DP&AR CSW/GGC/Trg., Room No. 310 & 311,  
Mizoram Secretariat (Building No - 2), MINECO Khatla, Aizawl.**
- (5) notice of withdrawal of candidature may be delivered either by a candidate  
or by any of his proposers or by his election agent who has been authorized  
in writing by the candidate to deliver it to either of the Officers specified in  
paragraph (2) above at his Office before **3:00 P.M. on the 23.10.2023  
(Monday)**.
- (6) in the event of the election being contested, the poll will be taken on  
**07.11.2023 (Tuesday)** between the hours of **07:00 A.M. and 04:00 P.M.**
